### Michigan DEQ Approves Kennecott Mining Application

Synopsis: On Tuesday, January 9, 2007 the Michigan Department of Environmental Quality (DEQ) issued a proposed decision to approve the mining permit for the sulfide mine on the Yellow Dog Plains. Public hearings are scheduled for March 6, 7, and 8 at NMU in the Michigan and Huron Rooms of the University Center.

While the story is far from over, a serious setback has just occurred. Throughout the permit application process for the proposed sulfide mine on the Yellow Dog Plains by Kennecott Minerals Co., numerous deficiencies have been pointed out to the Michigan DEQ in a series of public meetings, hearings, letters, faxes, and emails. According to a recent press release, the DEQ itself found 91 separate deficiencies in the permit applications. Despite all that, the DEQ has granted a preliminary approval. The next step in the process is a 3 day series of public hearings in Marquette on March 6, 7, and 8 in the Michigan and Huron Rooms of the University Center at Northern Michigan University.

It would be helpful for all concerned citizens to make their opinions about this issue clear to Governor Granholm as soon as possible. Contact information is:

### Solar Power Coming Online

Several high profile solar projects have been making the news lately. After a season of very high petroleum and correspondingly high electricity prices, some pioneers are starting to explore the feasibility of generating part or all of their own power with photo-voltaic (PV) cells.

Google Inc. (the internet search engine company) plans to build a massive PV system to help power its Mountain View, California campus. This system will consist of 9,212 solar panels and cover approximately 4 acres of building roof and carport roof space. This system is designed to have a total (continued)

capacity of 1.6 megawatts, or enough electricity to power 1,000 average homes. Current projections indicate that it will produce on average 30% of this site's electrical needs. PV systems such as this one will on some days provide very little power, however, and on others provide a surplus, which will be sold back to the power company. Google believes this investment will pay for itself in 5-10 years.

In a move that surprised many in the environmental movement, Wal-Mart has submitted a confidential "request for proposal" (RFP) document for companies to bid on supplying solar power generating systems to their stores in 5 states. Although details of the RFP are not public, the scope of this project is roughly in the 100 megawatt range, making it about 60 times the size of the Google project. It should be noted that the RFP does not obligate Wal-mart to go ahead with this expenditure.

Richard Branson, the founder of Virgin and Virgin Atlantic Airlines, and Ted Turner of Turner Broadcasting both recently announced large investments in renewable energy. Each hopes to help the environment and make some money.

What all this activity will hopefully mean to us is the critical mass of manufacturing will begun to be met, and prices could start to drop on alternative energy components so local generation of power may become feasible for more of us. This could be a good thing, because every ton of carbon dioxide and the related pollutants we keep out of the air means easier breathing for each one of us.

### Development Coming to Bond Falls, Victoria Lake, Prickett Lake?

Upper Peninsula Power Company/Wisconsin Public Service Corporation (UPPCO/WPSC) has held several public hearings and a cycle of closed sessions to gather input for Shoreline Management Plans (SMPs) for the various UP impoundments they plan to develop.

Members of FOLK attended several public hearings in the Western UP, but FOLK was denied a seat on the advisory board to the SMP group. Steering Committee member Ted Soldan was allotted a position as alternate for the Upper Peninsula Environmental Coalition seat, and was therefore able to attend one meeting. UPPCO/WPSC plans to petition the FERC (Federal Energy Regulatory Commission) to change the agreement they made regarding the project lands that surround all 3 impoundments. Such changes would, they believe, make the non-project lands they are selling more valuable by giving potential land owners better access to the water including docks. At the meetings, one group was strongly in favor of the proposed development, and supported the changes. The other group felt the agreements should remain in place in order to keep these impoundments in their wilderness state. There seemed to be very little middle ground. As of this writing, UPPCO/WPSC is in the process of developing the Shoreline Management Plans, based on input they received in these meetings.

Residents of Interior Township initiated a citizen petition drive that made the newspapers. Enough signatures were collected to put the rezoning of the land around Bond Falls to a vote of the township citizens. In an unusual move, the township clerk denied the petition. Now citizens from Interior Township are in the process of using the courts to put the rezoning before the voters.
